

**THE Verizon Love Is Blind Denver Fan Experience Flyaway SWEEPSTAKES
OFFICIAL RULES**

**NO PURCHASE NECESSARY. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.
VOID WHERE PROHIBITED**

The Verizon Love Is Blind Denver Fan Experience Flyaway ("Sweepstakes") begins on October 1st, 2025, at 12:00 a.m. Mountain Time (MT) and ends on October 8th, 2025, at 11:59 p.m. MT (the "Sweepstakes Period"). By participating in the Sweepstakes, each entrant unconditionally accepts and agrees to comply with and be bound by these Official Rules and the decisions of Verizon Corporate Services Group Inc. ("Sponsor"), which are binding and final in all respects.

1. ELIGIBILITY

The Sweepstakes is open to individuals who: (i) are at least 21 years of age at the time of entry in the Sweepstakes; (ii) are legal residents of the 50 United States and the District of Columbia; and (iii) are NOT in one or more of the "Prohibited Persons" categories listed below. Any entry submitted by any ineligible person(s) will be void.

Prohibited Persons. Once you have completed the foregoing, you must agree to the Official Rules and Privacy Policy and click the "submit" button (each an "Entry"). Entries must be received by 11:59:59 p.m. MT on October 8th, 2025. Data usage rates may apply to access the Sweepstakes microsite.

3. CONDITIONS APPLICABLE TO ALL ENTRIES

Limit one (1) entry per person and per email address. Sponsor's computer is the official time-keeping device for the Sweepstakes. All received entries become the exclusive property of Sponsor and will not be acknowledged or returned, and no correspondence will be entered into. Any attempt by an entrant to obtain more than the stated number of entries by using multiple/different email addresses, identities, registrations and/or logins, or any other methods will void that entrant's entries and that entrant may be disqualified if discovered by Sponsor. The use of automated entry devices or any other conduct that impedes the integrity of the Sweepstakes is prohibited. Potential prize winners must meet all eligibility requirements and comply with these Official Rules to qualify for the prize. The judging organization's decisions are final on all matters relating to the drawing. Limit one prize per person during the Sweepstakes Period.

Prize. One (1) winner and a guest will receive a round-trip flight to and from Denver. One hotel room from 10/28/25 to 10/30/25. Winner will also receive two (2) tickets to the Love Is Blind Denver Fan Experience to be held on 10/29/25 at Empower Field at Mile High (1701 Bryant St, Denver, CO 80204). The winner's guest must also be 21 years old or older at the time of the event. ID will be required for all attendees. Tickets include food and beverage, parking at the venue and access to the in-person event at Mile High Stadium (together, the "Prize"). **Combined ARV of the Prize is \$2,000.**

All expenses and costs not expressly listed above, including, but not limited to, federal, state or local taxes on the value of the prize, are the sole responsibility of the winner. Prize is not transferable, assignable, or redeemable for cash except at Sponsor's sole discretion. Prize details and availability are subject to change, in which case Sponsor may substitute a prize of equal or greater value. Any portion of prize not used by winner is forfeited and no cash substitute will be offered or permitted. Prizes are subject to all additional terms and conditions thereon. Prize offered is provided "as is" with no warranty or guarantee either express or implied by Sponsor. Sponsor is not responsible for loss, delay, or damage in delivery of Prize. 6. WINNER NOTIFICATION PROCESS

Sponsor will attempt to notify potential winners via email and/or phone, using information provided on the Entry form. Potential winners will be required to follow prize claim instructions provided and return all necessary prize claim documents within five (5) business days from the date of notification. Potential winners must complete and sign a Prize Acceptance & Liability Waiver and a Publicity Release before the

Prize will be awarded (TN residents need not sign the Publicity Release). The Prize will be forfeited in the event that: (i) the potential winner is not in compliance with these Official Rules, including any eligibility requirements; (ii) the prize notification or attempted notification is returned as undeliverable; (iii) Sponsor does not receive timely response to prize notification; or (iv) a potential winner declines the Prize offered.
